### Key Facts

<b>WHY</b>	In 2000 the EU declared that the US was in compliance with EU Directives on data security / privacy principles (known as the "Safe Harbour decision"). However, after several high profile customer complaints about data privacy and retention, the European Court of Justice (ECJ) declared in October 2015 that the Safe Harbour Decision was invalid.
<b>WHAT</b>	The EU General Data Protection Regulation ("GDPR") is a law designed to enhance data protection for EU residents and provide a consolidated framework to guide the usage of personal data across the EU. GDPR replaces all previous existing regulations and frameworks.
<b>WHEN</b>	The deadline for compliance is May 25, 2018.
<b>WHO</b>	If a company deals with EU personal data of any kind (employees, contractors, vendors, consumers, or customers), then research is required to assess if GDPR applies.
<b>IMPACT</b>	Non-compliance includes fines up to 20,000,000 EUR or 4% of total worldwide annual turnover of the preceding year (whichever is higher).
